Tax Adjustment Benefit (For Those with Insufficient Flat-Rate Tax Reductions)

<調整給付金(定額減税しきれない人への給付金)>

Conditions	Individuals who are eligible for a flat-rate tax reduction, and whose FY2024 estimated income tax or individual residence tax is expected to exceed the tax reduction received. *Only tax-paying individuals with a total income of 18,050,000 yen or less are eligible.	
Benefit Amount	The insufficient balance of the tax reduction • The total sum of insufficient income tax and residence tax reduction balance, rounded up to nearest 10,000 yen increment.	
Notification	Mailing of notifications (together with the benefit confirmation form) to eligible individuals began in late July.	
Application Method	Individuals must apply to receive the tax adjustment benefit. Please fill in the benefit amount along with your bank account information, and submit the benefit confirmation form. If you have already registered a bank account for receiving public funds and payment to that account is preferred, applications can be completed online. For further details, please check the notification received. *Please ensure to complete the application by the deadline date.



Chickenpox	From age 1 until the day before their 3rd birthday Note: vaccination is not necessary for children who have previously had chickenpox
Japanese encephalitis	Stage 1: From 6 months to the day before they turn 7 years and 6 months Stage 2: From age 9 to the day before their 13th birthday
Diphtheria or combined diphtheria-tetanus (DT) booster	From age 11 until the day before their 13th birthday
Human papillomavirus (HPV)	(1) Girls of elementary school grade 6 to high school age grade 1 (2) Women born between April 2, 1997 and April 1, 2008 who have not received their third vaccination
